### **AGENDA**

- 1. Review and approval of November's Minutes
  - Meeting Minutes were approved.
- 2. RFVHC Update Karin Offield

- Request to change project. Replace line item #17 with Signage/Education for the Trails Safe Passing Plan (TSPP) used in trail heads and kiosks where appropriate.
- Karin states she has Trade Marked the signs because the Roaring Fork Valley Horse
  Council would like to know where the sign is being used throughout the country. They
  have a form users can fill out on the Roaring Fork Valley Horse Council website so
  they can track who is using the sign.
- George brought up a concern of the new signage being duplicative of the yield signs
  that is already on the trails for horses. As well as the land management owners
  allowing Roaring Fork Valley Horse Council to put signs on their property. Karin
  assured George that the signs are different and this new signage is more
  informational. Karin also stated that she will work with the land management
  owners and get their approval for putting signs on their property.

## 3. 2023 Budget Review

- George decided to leave the \$5,000 budget for the Roaring Fork Valley Horse Council to
  use for the educational signs and potential gate projects as along as the Roaring Fork
  Valley Horse Council provided documentation of their spending of each project.
- Roaring Fork Outdoor Volunteers requested to remove the Adopt a Trail- Rio Grande line item. Roaring Fork Outdoor Volunteers spoke with RFTA and decided to not to pursue with it through the MVTC.
- Becca Schild introduced Melissa from Roaring Fork Outdoor Volunteers as their program director and main point of contact May-June because Becca will be on maternity leave during that time.
- Becca pointed out on the budget that the \$7,000 allotted to Roaring Fork Outdoor Volunteers for Community Education should actually be for Trail Maintenance. Becca had spoken to Temple about it previously, it just needs to be updated on the budget sheet. The correct budget sheet was not attached in the meeting agenda.
- Becca appointed Melissa to speak about Roaring Fork Outdoor Volunteers updates on the Nancy Path project and new Community Project Series. Sarah and Temple reminded Melissa and Becca if the committee needs to decide on anything all updates and presentations need to be submitted at least 10 days prior to the meeting in order for it to be included in the meeting.

#### 4. 2023 Work Plan

- Ideally the committee members would like to talk about each item on the work plan each
  meeting and hear an update from the following partnerships about the projects MVTC is
  funding.
- Remove Adopt a Trail from Roaring Fork Outdoor Volunteers work plan.
- Add Education Signage for the Roaring Fork Valley Horse Council work plan.
- There was clarification on the Nancy Path Project. The project is working on the
  equestrian trail connection from Nany's Path to Glassier trail. Angie requested a map
  during presentations of this project so it is clear. Melissa states Pitkin County is working
  on the alignment for the connection still, so there is not a map yet.

#### 5. New Business

Recruiting more MVTC members. George suggested to find people who are interested
in our projects. Angie said RFTA marketing can create an ad and suggests posting the
ad with Pitkin County Open Space and on the RFTA website. Becca said she will put out
an ad on the Roaring Fork Outdoor Volunteers newsletter and Karin said she will put an
ad in the Roaring Fork Valley Horse Council newsletter.

RFVHC Agenda Item for MTVC Meeting 1.13.2023:

### **EDUCATION:**

The <u>Trails Safe Passing ACTION Plan: Stop! Speak and Stand Back</u> (TSPP) will help trail users to know what to do when encountering equestrians on the trails.

This action plan has been a collaboration of user groups, hearing from and learning from many. A workshop began in Michigan in February 2020 with all trail partners and began the conversation. The equestrian trail leadership wrote the Trails Safe Passing Action Plan and now works with public land managers and trail user groups, with the addition of the Roaring Fork Valley Horse Council's new sign. (See below). The national and international renowned Equine Land Conservation Resource (ELCR) in Lexington, Kentucky agrees with and promotes this Action Plan with the RFVHC sign. The international arm of mountain biking, International Mountain Biking Association (IMBA) recognizes the TSPP.

It is recognized that many trail user groups are not aware that horses are prey animals and naturally can be afraid of unfamiliar people and objects. Their "flight & fight" instincts create fear, and horses can become unreliable. We also found the phrase "yield" was unclear and not understood by some people. For example,

trail users from other countries do not understand the word YIELD.

Most importantly, the Trails Safe Passing Plan (TSPP) is different because we are teaching users to Stop! when they first encounter horses on a trail. Using no bells in our plan, because horses cannot be trained to understand the "ring" nor do we give advice to "slowly pass" - our TSPP action plan becomes <u>safer for equestrians</u> and other trail users because we ask people meeting horses on the trail to first, STOP!!

Importantly, next we teach trail users meeting horses on the trails to SPEAK, to announce themselves and say "hi" to the horseback riders and strike up a conversation. Horses are nervous about meeting objects on the trails and the human voices can put horses at ease!

The final safety request is to <u>Stand Back</u> off to the side of the trail so the horses and their riders can enjoy <u>safe passing</u>. If you are passing and coming up from <u>behind a horse or a group of horses</u>. It is best for other trail users to STOP! as soon as they see the horseback riders and announce themselves, so <u>horseback riders can have time to turn their horses around to face the other trail users and prepare for <u>safe passing</u>.</u>

A safety aspect for all trail users and horseback riders works best when horseback riders pass hikers and bikers, horseback riders do so at a walk.


For these safety reasons, the Trails Safe Passing Plan was developed as an educational resource and action plan of WHAT TO DO when all of us meet horses and people with horses along the trails.

The RFVHC is asking the Mid Valley Trails Committee & RFTA and coalition of trail user groups to use our signs and QR Codes in your social media and ask that an allowance from our 2023 budget be used to pay for signage that educates trail users by the Trails Safe Passing Plan and the RFVHC sign, at Parking Lots and Kiosks as appropriate.

The signs are attached to this document, and a library of high resolution graphics are available for all of our use, on request.
